#### Min 1-21.02.14: Review of Last minutes

The last meeting's minutes were reviewed by the secretary and supported unanimously by members present as a true recording of what happened.

### Min 2-21.02.14: Group Registration and Naming

All members present concurred on the importance of registering the group with the relevant ministry of GoK. Each member present contributed Kshs. 50 to facilitate the process. The group delegated the task to Kamiti (research on all requirements for registration).

Members suggested possible names for the group like:

- I. Diversity Group
- II. G-Diversity
- III. Logic Group
- IV. Logic Link
- V. Investment Group 2014

However, none was picked as the official group name.

### Min 3-21.02.14: Group Constitution

After a brainstorming session; members drafted a constitution with the following rules stipulate:

- I. Each member shall contribute at least Kshs.500 per month with no maximum amount stated.
- II. The group shall convene regular meetings, at least on a quarterly basis.
- III. Failure to contribute monthly payment shall attract a penalty of 30% of the minimum instalment (currently Kshs. 150). This will also apply to late payment (according to rule IV below).
- IV. A member will be deemed to have defaulted in payment if the contribution has not reached the group on the last day of the month.
- V. A member cannot miss two consecutive meeting; else the offense will attract a fine of 50% of the minimum monthly instalment (currently Kshs.250).

#### Note

The above constitution is bound to grow as the group advances.
